The NYCMTE (New York Council of Massage Therapy Educators) meets annually and invites the State Board for Massage Therapy Executive Secretary to attend. In preparation for this year's meeting, we requested the Council send us questions they would like addressed at the meeting. We received a 6-page letter which listed issues the Council has with multiple items, including the massage therapy scope of practice and the NYS exam. AES Cottrell will forward the letter to the Board. She will also send a response to the Council informing them of the role of the State Board Office and outlining the process that needs to occur to change the law defining the scope of practice. The State Board Office cannot make changes to a profession's scope of practice. When proposed legislation comes to the State Education Department, the Board Office serves in an advisory role and provides technical assistance regarding the proposed legislation to the Board of Regents.

The Governor's Executive Order 11.5 declaring a disaster emergency was extended to May 15, allowing today's meeting to be held online. The Governor has been extending this order on a regular basis, but we do not know if it will be extended again. Our next meeting may need to be in person.

The next Massage Therapy Board Meeting will be held on Friday, September 16; to be determined if meeting will be in-person or via Zoom.
